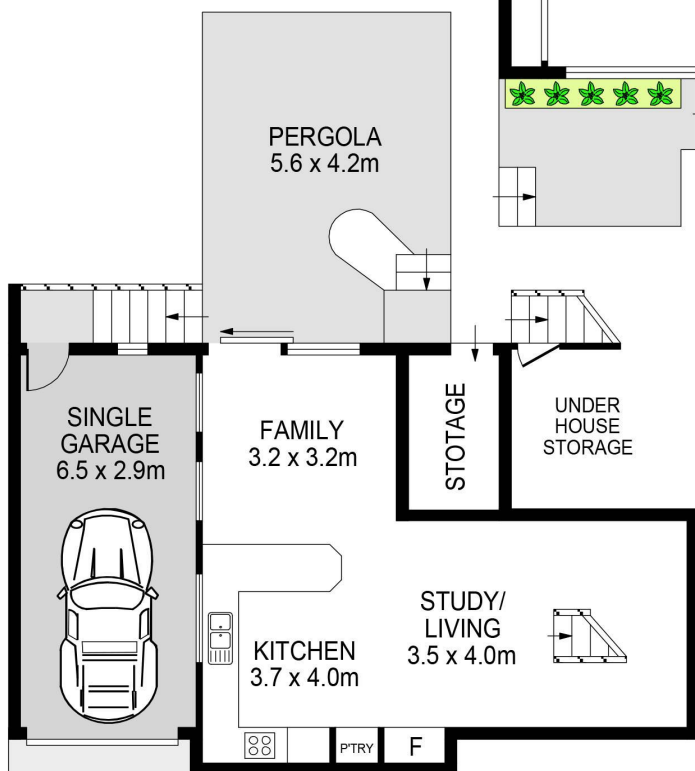




SITE PLAN
